

# Joint SCAR/CEP Workshop on Further Developing the Antarctic Protected Area System

## Workshop Note #2

### Summary

There were no suggestions for changes to the proposed workshop planning schedule presented in Workshop Note #1. Following nominations for additional representatives to participate on the workshop steering committee, the steering committee has been expanded to a total of 10 participants. ### Background

Workshop Note #1 provided background to the Committee's decision at CEP XXI to convene a joint SCAR/CEP workshop on further developing the Antarctic protected area system, and provided information about the timing and location of the workshop.
