SCAR Executive Committee Meeting 2017 Brno, Czech Republic, 31 July - 2 August 2017

Summary (<150 words):

This report provides a short update on matters relating to the Development Council since the previous report given in Kuala Lumpur. The major activity has been the composition and sending to all SCAR Delegates and Group Leaders of a letter setting out our view of their key role in identifying and in many likely cases initially pursuing possible avenues of funding or other support at their national level for the benefit of SCAR activities. This generated a number of supportive responses, and three new funding contributions towards the Visiting Fellowship and Professorship programmes, from India, Norway and Switzerland.

Recommendations that EXCOM should consider (if any): *Please indicate if approval is necessary or if they are just asked to note information.*

1) SCAR to record formal appreciation of the increased and/or new contributions of India, Norway and Switzerland towards the Visiting Fellowship and Visiting Professorship programmes

2) DC recommends that EXCOM initiate a review of the Visiting Professor programme to date, in particular to identify the extent to which it is achieving the aims for which it was set up, and consider ways in which to develop the applicant field to further these aims. In particular, we ask EXCOM to consider if and how a more active role could be taken in identifying real value capacity building contributions the programme could make to newer and less established programmes.

3) DC requests to maintain the current budget allocation for pamphlet preparation and creation of funding database once new website is sufficiently developed.

Background:

This report provides a short update on matters relating to the Development Council since the previous report given in Kuala Lumpur.

The major activity has been the composition and sending to all SCAR Delegates and Group Leaders of a letter setting out our view of their key role in identifying and in many likely cases initially pursuing possible avenues of funding or other support at their national level for the benefit of SCAR activities. This letter was sent jointly by Karin Lochte and Peter Convey.

Progress:

Development Council members present at the recent SCAR Biology meeting in Leuven, Belgium, met to update on progress following the sending of the letter. Those present were Peter Convey, Karin Lochte, Jose Xavier and Jenny Baeseman. Notes and actions from this meeting are set out below:

In November 2016 a letter from Karin and Pete was sent to each SCAR Delegate as well as to leaders of all SCAR groups. Responses from Delegates are noted in the appendix below. In general, most who responded were positive and supportive of the efforts, but it is also perhaps disappointing to note that no response at all was received from a majority of the countries/national delegates contacted. Of the countries that appreciated the request, most indicated it would not at present be feasible for them to contribute, although some noted that they would try to take the request further within their systems.

Action: Karin Lochte to follow up with countries that expressed interest in potentially contributing.

With much appreciation, India contributed \$12.500 USD for an additional fellowship, as well as \$2.500 USD for an additional Visiting Professorship. In addition, both Norway and Switzerland contribute \$2.500 USD each for additional Visiting Professorships.

A brief discussion was had on how we might increase the number and quality of Visiting Professor applications. It was suggested that it might be a good time to do a review of the programme to see if it has been successful and if it has accomplished what SCAR set out to achieve.

Action: Karin Lochte and Pete Convey to bring this forward as an action proposal for the ExCom meeting.

In this discussion, it was also brought up that SCAR might think about how to help new countries in identifying what they feel they need to engage with in SCAR and facilitate helping them with those issues. It was also mentioned that perhaps some of the senior SCAR leaders could be asked to help in this regard by visiting these countries and helping them learn more about SCAR. Fellowships were also briefly discussed and it was felt that the number of applications at this stage is appropriate given the current funding level (approximately 5-6 applicants per fellowship awarded). If, as hoped for, funding increases, then it will be appropriate to make additional efforts to encourage and expand the field of applicants.

In the funding context, Pete brought up the discussions initiated at the OSC in Kuala Lumpur with IAATO on funding fellows. Jenny suggested Pete discuss this with Steven before picking this up with the new IAATO Executive Director.

Action: Pete Convey to discuss IAATO collaboration with Steven Chown and progress accordingly. [note: discussion initiated during Biology meeting, with both Steven and Damon Stanwell-Smith, new IAATO ED]

The creation of the SCAR book/pamphlet to be used on tourism ships was discussed. Karin had produced an outline at the SCAR OSC in Kuala Lumpur, but progress has been slow.

Action: Karin to continue to work on the book/pamphlet later in 2017.

The Development Council was allocated a budget for the book/pamphlet as well as the creation of a funding database. These funds have not yet been used. The content for the database is coming together, but development of the tool is on hold until the new website is completed.

Future Plans:

As noted above, a number of individual actions have been identified to progress specific elements of DC work.

Budget

Planned use of funds for 2017 and 2018

Briefly describe what the funds will be used for and what the desired results are:

As previously, funds are requested for development of a SCAR pamphlet for distribution to IAATO vessels, and towards development of a funding database. As also noted previously, SCAR needs to be able to be responsive to identified specific funding opportunities as and when they arise, and therefore some flexibility in funding allocation is required. The intention is for formal DC meetings to take place in the wings of the major SCAR meetings, with the next being in Davos in 2018.
